2. Meeting Minutes:

- Motion to approve the January 2023 meeting minutes by Kevin Chaloupecky, Karen Hatch 2nd.

- A correction to the January 2023 meeting minutes was noted. The January 28, 2023 clinician was to be noted as Alexander Pershounin, however was noted erroneously in the minutes as Mr. Patterson.

3. Treasurer's Report:

It is noted that the pull must be public and is planned to be selected prior to band class at the end of February. A flier is being created with details.

- Keri Songer visited the WBPO meeting to share information pertaining to Winter Guard.
 - The first show is in one week in Marion, followed by a show in MN during the first week of March, and the home show on March 25, 2023.
 - There was a very good turnout of interested students from both high schools and all middle schools. There are 23 high school students and 19 middle school students.
 - RevTrak was set up by the district for donations. The recommended donation for high school students is \$250. An email will be sent to parents requesting donations, and then Keri will approach both band parent organizations to discuss possible assistance.
 - T-shirt purchases for the middle school winter guard "uniform" were discussed with potential for the WBPO to cover the cost of the south feeder middle school student participants.
 - Keri noted that the floor was purchased in 2019 and is showing wear with some holes. She noted it does not need to be replaced right now, but will need to be replaced in the future.
